

**FACTS****WHAT DOES REVOLUT TECHNOLOGIES, INC AND REVOLUT SECURITIES INC DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and other identity information;
- Account Balances, payment history and transaction history;
- Credit history, credit scores, and employment information; and
- Bank account, financial and income information.

**How?**

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Revolut chooses to share; and whether you can limit this sharing.

| <b>Affiliates</b>   | <p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ Our affiliates include financial companies with Revolut in their name such as Revolut Ltd and Revolut Holdings US Inc.</li> </ul>   |
| <b>Nonaffiliates</b>  | <p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ Revolut US does not share with nonaffiliates so they can market to you.</li> </ul>  |

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Revolut US does not jointly market.

**Other important information**

**Important Notice about Credit Reporting:** We may report information about your account(s) to credit bureaus and/ or consumer reporting agencies. Late payments, missed payments, or other defaults on your account(s) may be reflected in your credit report and/or consumer report.

**California residents:** Under California law, we will not share information we collect about you outside of Revolut's affiliated companies unless permitted by law. We may share information with your consent, or to offer our products and services to you and to provide customer service. We will limit sharing amongst Revolut companies to the extent required by California law.

**Nevada residents:** Nevada law requires us to tell you that you may request to be placed on our internal "do not call" list at any time by emailing [dpo@revolut.com](mailto:dpo@revolut.com). We are providing this notice to you pursuant to state law. **Vermont residents:** Under Vermont law, we will not share information we collect about you outside of Revolut's affiliated companies unless permitted by law. We may share information if you consent, to offer our products and services to you, or to provide customer service. We may share information about your account with our affiliated companies, but we will not share information about your credit history with our affiliated companies unless you provide consent.
